

PRESIDENT'S CORNER

Dear FAPA members and friends:

Greetings! A lot has happened since late March.

Firstly, you are likely aware of the controversial and unconstitutional "legislative reform" bills pushed through in May by Taiwan's main opposition Kuomintang (KMT) and the smaller Taiwan People's Party (TPP). These bills not only exceeded the bounds of those found in constitutional democracies around the world but also undermined the rule of law and parliamentary procedures, as criticized by a joint statement of May 20 cosigned by 30 international scholars and experts, including me.

Forcibly passed with considerable haste and secrecy, the KMT-TPP's "legislative reform" package prompted large-scale protests (known as the Bluebird Movement) by the Taiwanese, primarily young people. The movement subsequently gained international attention as many overseas Taiwanese youths began to organize in solidarity.

FAPA, together with the World Federation of Taiwanese Associations (WFTA), initiated a joint statement in late May, expressing solidarity with the Bluebird protestors to defend Taiwan's democracy. This statement, signed by more than 60 overseas Taiwanese organizations across the U.S., Europe, South and Central America, Japan, Australia, and more, is a testament to the strength and unity of the overseas Taiwanese communities.

The 2024 Emerging Leaders Workshop (ELW) — with the theme "U.S.-Taiwan Relations in an Age of Uncertainty" — took place from June 23 to 28 and was a great success. This year, 29 incredible Emerging Leaders from Taiwan and across the U.S. came to Washington, D.C., to learn more about U.S.-Taiwan relations, Washington and U.S. Congress perspectives, and why and how to "Keep Taiwan Free." We are delighted about the overwhelmingly positive feedback from the ELW participants, who, after our training, will become the next generation of Taiwanese and Taiwanese American experts and advocates on U.S.-Taiwan relations.

In the past months, I have visited seven local chapters, including Albany, Syracuse, and Rochester chapters in upstate New York, Maryland chapter in Baltimore, Texas-Central chapter in Austin, and Orange County and Sacramento chapters in California. It was so wonderful to reconnect with old friends and meet new ones. In particular, it was such an honor meeting two legendary figures — Mr. Chung-Chin Chen (陳仲欽), who wrote a letter to then-Senator Joe Biden for the unjust treatment of Kaohsiung Incident victims in 1979, and Mr. Chen Hsu (許辰沼), who was one of the founding fathers of FAPA who met with then-Congressman Steve Solarz in 1981 advocating for a separate 20,000 annual immigration quota for Taiwan. I was thrilled and deeply moved by our FAPA members' tremendous support and enthusiasm.

Our engagement with the Taiwanese American community is also a major agenda. To that end, our HQ team attended the Taiwanese American Conferences in July. On the East Coast, FAPA Executive Director Anny Hsiao delivered a top-notch keynote speech at the TACEC, talking about Taiwanese American grassroots activism and FAPA's continued advocacy efforts. We also conducted a workshop at Taiwanese American Next Generation (TANG), sharing the stories of FAPA's early and current advocacy efforts with the 2nd and 3rd generations of Taiwanese Americans.

On the West Coast, at the TAC-WC held in Los Angeles, Anny Hsiao delivered another inspiring speech in which she reflected on FAPA's founding in the city in 1982. We also had the chance to speak with some of the earliest advocates for Taiwan in the United States, and participated in a panel with Emerging Leaders Workshop alumni and Southern California chapter presidents. These events provided valuable opportunities to strengthen our ties with the Taiwanese American community and honor our shared history.

In early July, we launched a petition campaign urging the U.S. Senators to support and pass the "Taiwan International Solidarity Act," which aims to counter China's distortion of U.N. General Assembly Resolution 2758 and its fabricated claim of sovereignty over Taiwan. If you haven't signed this petition, please do so on FAPA's website — it is easy and only takes 3 minutes.

On the opening day and near the end of the 2024 Paris Summer Olympics, we issued respectively a FAPA statement and a joint letter by 24 overseas Taiwanese organizations, calling on the International Olympic Committee (IOC) to let Taiwanese athletes compete under the name "Taiwan" instead of forcing Taiwan's team to use the discriminatory misnomer "Chinese Taipei." The FAPA statement and joint letter were huge successes and have been reported across multiple media outlets. I commend and thank HQ staff for working round the clock to release the statement and the joint letter in a timely fashion to bring the world's attention to this important issue.

Lastly, I want to invite you all to the upcoming National Advocacy Conference on September 7-9, 2024. You will learn about grassroots advocacy strategies, U.S.-Taiwan policy, and FAPA's issues of concern. After the two-day workshop, we will all go to Capitol Hill on the following Monday and put into action what we learned at the workshop.

Thank you for your continued support for and dedication to FAPA. Together, we can make a difference and create a brighter future!

會長的話

親愛的FAPA會員及朋友:

大家好! 自3月底以來,已有許多值得報告的事。容我與您分享。

首先,各位可能已經知道,台灣的主要反對黨「中國國民黨」和較小的「台灣民眾黨」在5月共同推動了一系列高度爭議且違憲的所謂「國會改革」法案,企圖大幅擴張立法院的權力。正如包括我在內的30名國際學者專家於5月20日所發表的連署聲明中所批評,這些法案不僅超越了國際各憲政民主國家的規範,更嚴重破壞了法治理念及議會程序正義。

藍白陣營的立法委員在極短時間內,且在未經充分討論的情況下,強行通過了這些法案,導致台灣民眾(尤其是青年族群)的強烈不滿,進而引發了「青鳥行動」的大規模抗議。隨著海外台灣青年紛紛組織起來聲援,該運動也受到國際社會的廣泛關注。

5月底,FAPA與世界台灣同鄉會聯合會(WFTA)共同發起一份連署聲明,表達對「青鳥行動」抗議者的堅定聲援,並支持台灣人民捍衛民主的決心。這份由美國、歐洲、中南美洲、日本、澳洲等地60多個海外台灣人社團所共同簽署的聲明,彰顯了世界各地台裔社群對於守護台灣民主的同心協力與團結一致。

2024年「台灣年輕世代領袖培訓營」(ELW)於6月23日至28日成功舉行,本次營隊主題為「不確定年代下的美台關係」。來自台灣及美國各地的29位優秀年輕領袖齊聚華盛頓特區,學習並深入了解美台關係、華府與美國國會的觀點、以及為何與如何「維護台灣自由(Keep Taiwan Free)」。我們很高興能得到ELW學員的正面反饋與高度肯定,他們將成為下一代台灣籍及台裔美籍的美台關係專家及倡議者。

在過去的幾個月裡,我共拜訪了7個FAPA地方分會,包括紐約上州的Albany、Syracuse、Rochester分會,位於巴爾的摩的Maryland分會,在奧斯汀的Texas-Central分會,以及加州的Orange County與Sacramento分會。能與各地的老朋友重聚及結識新朋友,並親身見證我們FAPA會員們的熱情支持與鼓勵,令我感到無比開心並深受感動。特別是很榮幸能見到兩位傳奇人物:一位是陳仲欽先生,他為1979年高雄事件(美麗島事件)受害者所受的不公正待遇而致信當時的美國聯邦參議員拜登(Joe Biden);另一位是許辰沼先生,他是FAPA的創始會員之一,他們曾於1981年拜會時任美國聯邦眾議員索拉茲(Steve Solarz),倡議為台灣提供每年二萬名的單獨移民配額。

持續深耕台美人社群,也是我們關注的重點之一。今年7月,我們總部團隊積極參與了美國東岸及西岸的台美人夏令會。FAPA執行長蕭喬勻(Anny Hsiao)在美東台灣人夏令會(TACEC)發表了精彩的主題演講,談論台美人的草根運動和FAPA長年的倡議努力。我們也在Taiwanese American Next Generation(TANG)舉辦了一場研討會,與年輕的第二代、第三代台美人分享FAPA早期與當前倡議工作的故事。

在洛杉磯舉行的美西台美人夏令會(TAC-WC)上,蕭喬勻執行長發表了另一場激勵人心的演講,並回顧了FAPA於1982年在該市成立的歷史。我們也趁此難得機會與美國最早期的一些台灣倡議者進行了交流,並與「台灣年輕世代領袖培訓營」的前學員及南加州各FAPA分會的會長們共同舉辦了一場座談會。這些活動提供了寶貴的機會,讓我們加強與台美人社群的連繫,並一起緬懷與分享我們的共同歷史。

7月初,我們發起了一項請願活動,敦促美國聯邦參議員支持並儘速通過《台灣國際團結法》 (Taiwan International Solidarity Act),以反制中國歪曲聯大第2758號決議及對台灣主權的虛假 主張。如果您尚未參與此請願,請至FAPA官網簽署請願書 — 這非常簡單,只需花您3分鐘的時間即 可完成。

在2024年巴黎夏季奧運的開幕日及其尾聲,我們分別發表了一項FAPA聲明、以及由24個海外台灣人組織連署的信函,呼籲國際奧委會(IOC)讓台灣的運動員得以「台灣」的名義參賽,而非強迫台灣代表隊使用「中華台北」這個帶有歧視性的誤稱。此FAPA聲明與連署信函皆相當成功,並被許多家媒體所報導。我要讚揚並感謝總部員工的辛勤工作,及時發布此聲明與連署信,提升世界對此重要議題的關注。

最後,我誠摯邀請各位參加我們即將到來的2024年全國倡議大會,時間為9月7日(星期六)至9月9日(星期一)。與會者將學習草根倡議策略、美台政策、以及FAPA關注的議題。在為期兩天的研討會後,我們將在緊接的週一前往國會山莊,共同為友台法案及政策發聲,應用所學、爭取美國國會議員們的支持。

我也要感謝您長期以來對FAPA的堅定支持與貢獻。只要齊心齊力,我們必能攜手帶來改變,共創更 美好的未來!

REP. BERGMAN LEADS CONGRESSIONAL DELEGATION TO TAIWAN

A U.S. Congressional delegation led by Representative Jack Bergman (R-MI) arrived in Taiwan on March 27 for a three-day visit. Other members of the delegation include Representatives Donald Norcross (D-NJ) and Jimmy Panetta (D-CA).

During their meeting with President Tsai Ing-wen on March 28, Chairman Bergman stated that "Taiwan is a key U.S. partner in the Indo-Pacific, both through strong security cooperation and economic ties," adding that their delegation is here to show U.S. Congress's continued support for Taiwan amid China's increasingly aggressive actions in the region.

President Tsai thanked the U.S.
Congress and government for helping bolster Taiwan's self-defense and further strengthening the Taiwan-U.S. partnership through various legislation and concrete actions. She also called on the visiting U.S. lawmakers to help resolve the Taiwan-U.S. double taxation issue at the earliest possible juncture.

PRESIDENT BIDEN SIGNS SPENDING BILL INTO LAW, PROVIDING MILITARY AID AND OTHER MEASURES TO SUPPORT TAIWAN

On March 23, U.S. President Joe Biden signed into law a US\$1.2 trillion spending package that includes US\$300 million in military aid to Taiwan, as well as funding for U.S.-Taiwan cooperative projects.

The "Department of State, Foreign Operations, and Related Programs Appropriations Act, 2024" in the spending package prioritizes funding for U.S. national security interests in the Indo-Pacific and strengthening the defense needs of Taiwan, including not less than US\$300 million in "Foreign Military Financing" (FMF) for Taiwan, and US\$400 million for the "Countering PRC Influence Fund."

The act also provides that "none of the funds made available by this Act should be used to create, procure, or display any map that inaccurately depicts the territory and social and economic system of Taiwan and the islands or island groups administered by Taiwan authorities."

BIDEN REITERATES IMPORTANCE OF CROSS-TAIWAN STRAIT PEACE DURING PHONE CALL WITH XI

U.S. President Joe Biden reiterated the importance of maintaining peace across the Taiwan Strait, in a phone call with Chinese President Xi Jinping on April 2. The phone discussion was their first direct communication since an in-person meeting in Woodside, California in November 2023.

Biden "emphasized the importance of maintaining peace and stability across the Taiwan Strait and the rule of law and freedom of navigation in the South China Sea," according to a White House readout released after the call.

REP. TOM TIFFANY: TAIWAN IS ALREADY INDEPENDENT!

In response to White House National Security Communications Adviser John Kirby stating that "We don't support independence for Taiwan," U.S. Representative Tom Tiffany (R-WI) tweeted on April 4: "Fact: Taiwan is already independent. Fact: Taiwan has never been part of Communist China even for one day. That's the real 'status quo."

BIDEN, KISHIDA AFFIRM IMPORTANCE OF CROSS-TAIWAN STRAIT PEACE

U.S. President Joe Biden and Japanese Prime Minister Fumio Kishida affirmed the importance of maintaining peace across the Taiwan Strait, during their meeting in Washington D.C. on April 10.

At a press conference after the meeting, Biden commended Kishida for "standing strong with the United States as we stand up for freedom of navigation, including in the South China Sea, and as we maintain peace and stability across the Taiwan Strait."

In a joint statement issued after their meeting, Biden and Kishida expressed a common stance on Taiwan: "We emphasize that our basic positions on Taiwan remain unchanged and reiterate the importance of maintaining peace and stability across the Taiwan Strait as an indispensable element of global security and prosperity. We encourage the peaceful resolution of cross-Strait issues."

PRESIDENT BIDEN SIGNS SECURITY SUPPLEMENTAL BILL INTO LAW, INCLUDING BILLIONS IN MILITARY AID FOR TAIWAN AND POTENTIAL TIKTOK BAN

On April 24, U.S. President Joe Biden signed into law a national security supplemental appropriations package, which would provide billions in military aid to Taiwan and includes the provision to "divest or ban" TikTok.

The package provides US\$8.1 billion for Indo-Pacific security, including US\$1.9 billion to replenish defense equipment and provide military services and personnel training to Taiwan, as well as US\$2 billion in foreign military financing (FMF) for Taiwan and other key allies in the region.

The provision to "divest or ban" TikTok would ban TikTok in the U.S. unless its parent company, the Chinese Communist Party-controlled ByteDance, sells the TikTok app.

Referring to the military aid to Taiwan, FAPA Executive Director Chiao-Yun Anny Hsiao said in a press release: "We Taiwanese Americans wholeheartedly welcome and thank both houses of Congress and the President for their willingness to invest in American capabilities to ensure peace and stability across the Taiwan Strait. As a key partner of the United States in the Indo-Pacific, Taiwan must remain free, sovereign, and independent."

Regarding the TikTok ban, Hsiao noted: "We should be cognizant of the threats that TikTok, in its current form, imposes on our national security. The Chinese Communist Party can capitalize on data from American users, and information that young Americans consume is manipulated in some way to favor Beijing's propaganda. We welcome Congress's and the President's support for the divestment and look forward to building a safer information space for all Americans."

U.S. REPRESENTATIVES URGE INTERNATIONAL OLYMPIC COMMITTEE TO USE "TAIWAN" INSTEAD OF "CHINESE TAIPEI"

On May 2, three U.S. House Republicans urged the International Olympic Committee (IOC) to stop requiring Taiwan's athletes to compete under the name "Chinese Taipei," accusing the committee of capitulating to "bullying" from the People's Republic of China.

The IOC is discriminating against Taiwan by requiring it to use the "Chinese Taipei" name as well as barring the display of Taiwan's national flag and the playing of its national anthem during the games, U.S. Representatives Tom Tiffany (R-WI), Andy Ogles (R-TN), and Chris Smith (R-NJ) said in their letter to IOC President Thomas Bach.

"This is not just unfair, it violates the core tenets of the Olympic Charter, which declares that '[e]very individual must have the possibility of practicing sport, without discrimination' and that 'the Olympic Movement shall apply political neutrality," they said.

U.S. LAWMAKERS CALL UPON D.C. MAYOR TO ESTABLISH SISTER CITY RELATIONS WITH TAIPEI

Congressional Taiwan Caucus Co-Chair Representative Andy Barr (R-KY), Chairman John Moolenaar (R-MI) of the House Select Committee on the Chinese Communist Party, alongside U.S. Senators Marco Rubio (R-FL) and Pete Ricketts (R-NE), wrote to Washington D.C. Mayor Muriel Bowser, calling on her administration to establish sister city ties with Taipei, Taiwan.

The lawmakers write, "We write to urge you and your administration to establish sister city ties with Taipei. Congress, and the city of Washington, D.C., have long played a leading role in U.S.-Taiwan relations, and the greater Washington metropolitan area is home to one of the largest Taiwanese American populations in the country."

SENATORS MARKEY, RUBIO, COLLEAGUES URGE BIDEN ADMINISTRATION TO FINALIZE AGREEMENT WITH TAIWAN TO IMPLEMENT TAIWAN FELLOWSHIP PROGRAM

On May 15, Senators Edward J. Markey (D-MA) and Marco Rubio (R-FL), along with a bipartisan group of their Senate colleagues, wrote to Secretary of State Antony Blinken, urging the U.S. Department of State to swiftly finalize an agreement with Taiwan to implement the Taiwan Fellowship program to allow its first fellows to arrive in Taiwan by the end of 2024.

The Taiwan Fellowship Act, introduced by Sens. Markey and Rubio in 2021 and passed into law in 2022 as part of the National Defense Authorization Act for Fiscal Year 2023 (FY 2023 NDAA), will establish a fellowship exchange program for U.S. federal government employees to live in Taiwan and work for Taiwan ministries, agencies, or parliamentary offices or other organizations related to their home agency work. Fellows will also learn Mandarin Chinese language in Taiwan.

U.S. IS "DEEPLY CONCERNED" ABOUT CHINA'S MILITARY DRILLS AROUND TAIWAN

On May 23 and 24, China conducted large-scale military exercises, codenamed "Joint Sword-2024A," around Taiwan in what they described as "punishment" for the inauguration of President Lai Ching-te. The drills sparked concern and condemnation among the international community.

"The United States is deeply concerned over the People's Liberation Army joint military drills in the Taiwan Strait and around Taiwan," U.S. Department of State Spokesman Matthew Miller said on May 25. "We are monitoring PRC activities closely and coordinating with allies and partners regarding our shared concerns," he added.

BIDEN WILLING TO USE FORCE TO HELP ALLIES

On May 25, U.S. President Joe Biden affirmed his willingness to protect the U.S.' allies and reiterated that peace in the Taiwan Strait should be upheld, as Washington again called on Beijing to restrain itself after it conducted two-day military drills around Taiwan.

"I've always been willing to use force when required to protect our nation, our allies, our core interests. When anyone targets American troops, we will deliver justice to them," Biden said in a speech to cadets graduating from the U.S. Military Academy in West Point, New York.

"We're standing up for peace and stability across the Taiwan Strait," he added.

REP. MCCAUL LEADS BIPARTISAN HOUSE DELEGATION TO TAIWAN, GIFTING PRESIDENT LAI FAPA AD

On May 26, a bipartisan group of U.S. Representatives from the House Foreign Affairs Committee, led by Chairman Michael McCaul (R-TX), landed Taipei to meet with the newly inaugurated Taiwan administration and demonstrate support for Taiwan amid China's relentless coercion.

The delegation also included Rep.
Jimmy Panetta (D-CA), Subcommittee on the Indo-Pacific Chairwoman Young Kim (R-CA), Subcommittee on Middle East, North Africa, and Central Asia Chairman Joe Wilson (R-SC), Rep. Chrissy Houlahan (D-PA), and Rep. Andy Barr (R-KY).

"Taiwan is a thriving democracy. The U.S. will continue to stand by our steadfast partner and work to maintain the status quo across the Taiwan Strait. I look forward to meeting with Taiwan officials to better understand what America can do to preserve peace in Asia and build upon our shared democratic values," Chairman McCaul remarked.

On May 27, the delegation gifted President Lai Ching-te a copy of the Washington Times of May 20, showcasing a FAPA ad congratulating President Lai and Vice President Hsiao Bi-khim on their inauguration.

SENS. DUCKWORTH, SULLIVAN LEAD BIPARTISAN SENATE DELEGATION TO TAIWAN

On May 29, Taiwan President Lai Chingte welcomed a bipartisan U.S. Senate delegation, calling the visit a demonstration of the solid partnership between Taiwan and the United States.

Led by U.S. Senators Tammy Duckworth (D-IL) and Dan Sullivan (R-AK), both members of the Senate Armed Services Committee, the delegation also included Senators Laphonza Butler (D-CA) and Chris Coons (D-DE).

"I've always believed that if America wants to remain a global leader, we have to show up and support our friends like Taiwan . . . who are facing escalating threats from the PRC as they work to strengthen their own democracy," said Sen. Duckworth.

"We're here in Taiwan to demonstrate to the world that the United States stands firm with the island democracy of Taiwan and to congratulate the Taiwanese people on another successful election and transfer of power," said Sen. Sullivan.

Sens. Duckworth, Sullivan, and Coons had previously traveled to Taiwan in 2021 to announce a U.S. donation of vaccines to Taiwan during the COVID-19 pandemic.

BIDEN REAFFIRMS POSSIBILITY OF USING U.S. MILITARY TO DEFEND TAIWAN

U.S. President Joe Biden said he won't rule out use of U.S. military force to defend Taiwan in response to a potential Chinese invasion.

In an interview with Time magazine published on June 4, Biden said whether the U.S. would use military force to help protect Taiwan will depend on whether "China unilaterally tries to change the status [quo]" across the Taiwan Strait.

If China tries to change the status quo unilaterally, "we're continuing to supply capacity [to Taiwan]," Biden said. "We've been in consultation with our allies in the region."

In the case of a Chinese invasion, Biden said he is "not ruling out using U.S. military force" to defend Taiwan, adding that there's "a distinction between deploying on the ground, air power and naval power, etc."

Prior to the interview, Biden had said on at least four separate occasions that the U.S. would defend Taiwan in the event of attacks by China, since taking office in 2021.

U.S. APPROVES US\$300 MILLION SALES OF F-16 PARTS TO TAIWAN

The U.S. Department of State has approved two potential sales to Taiwan of F-16 parts and related equipment worth a total of US\$300 million, the Pentagon announced on June 5. The deals represented the 14th U.S. arms sale to Taiwan since President Joe Biden took office in 2021.

In two press releases, the Pentagon's Defense Security Cooperation Agency (DSCA) said the packages would include standard (US\$220 million) and non-standard (US\$80 million) spare and repair parts, components, consumables, and accessories for F-16 aircraft, as well as other technical and logistics support services.

The proposed sales would improve Taiwan's ability to "meet current and future threats by maintaining the operational readiness of [Taiwan's] fleet of F-16 aircraft," the DSCA said.

They would also help improve the security of Taiwan and assist in maintaining political stability, military balance, and economic progress in the region, the DSCA added.

U.S. ELECTED OFFICIALS COMMEMORATE TAIWANESE AMERICAN HERITAGE WEEK (TAHW) 2024

The year of 2024 marks the 25th anniversary of the first proclamation of Taiwanese American Heritage Week (TAHW) signed by President Bill Clinton in 1999.

From Mother's Day May 12 to May 19, 2024, we Taiwanese Americans celebrated our annual TAHW across the nation, and joined hands to reach out to the general American public to share our heritage.

This year, 23 U.S. elected officials issued proclamations or letters to honor the contributions that we Taiwanese Americans have made to the diversity and prosperity of American society over the past decades, and our contributions to the promotion of democracy and security of Taiwan.

U.S. APPROVES \$360 MILLION SALES OF SUICIDE DRONES TO TAIWAN

The U.S. Department of State has approved the sales of two types of loitering munitions, also known as suicide or kamikaze drones, to Taiwan for US\$360 million, the U.S. Defense Security Cooperation Agency (DSCA) said on June 18. The deals represented the 15th round of U.S. arms sales to Taiwan announced by the Biden administration since 2021.

Included in the two separate packages are 720 Switchblade 300 loitering munition systems and related equipment for an estimated cost of US\$60.2 million, and 291 ALTIUS 600M-V suicide drone systems and related equipment for an estimated cost of US\$300 million, the DSCA said.

Loitering munitions fly around an area until a target is located, then attack by crashing into it.

U.S. STRONGLY CONDEMNS CHINA'S NEW GUIDELINES TARGETING TAIWAN INDEPENDENCE ADVOCATES

The United States strongly condemned China's "escalatory and destabilizing language and actions" toward Taiwan after Beijing announced new judicial guidelines to punish supporters of Taiwan independence.

During a press briefing on June 24, U.S. Department of State Spokesman Matthew Miller was asked about the People's Republic of China's (PRC) guidelines released on June 21 that included the death sentence for people deemed as "diehard" advocates of Taiwan independence.

"We strongly condemn the escalatory and destabilizing language and actions from PRC officials," Miller said. "We continue to urge restraint and no unilateral change to the status quo."

The U.S. urges the PRC to "engage in meaningful dialogue with Taiwan," Miller said, adding that "threats and legal warfare will not achieve peaceful resolution to cross-strait differences."

U.S. "DEEPLY CONCERNED" ABOUT CHINA'S LATEST LEGAL WARFARE AGAINST TAIWAN: STATE DEPARTMENT OFFICIAL

During a Congressional hearing on June 27, Daniel Kritenbrink, Assistant Secretary of State for East Asian and Pacific Affairs, said that the United States is "deeply concerned" about China's new legal guidelines targeting advocates of Taiwan independence, and "if passed as prologue, we're concerned that China could apply these regulations to others overseas as well."

The guidelines may not only be used for extraterritorial application of Chinese law in ways that are deeply disturbing but could also have a chilling effect on cross-Taiwan Strait dialogue and interaction, Kritenbrink said.

China's move was clearly designed to intimidate people and prevent them from candidly expressing their opinions about the situation across the Taiwan Strait, he added.

U.S. DELEGATION VOWS TO SUPPORT TAIWAN AGAINST "MORE AGGRESSIVE CHINA"

On June 25, a visiting delegation from the U.S.-China Economic and Security Review Commission (USCC) met with Taiwan President Lai Ching-te in Taipei and pledged to support Taiwan as it faces "a more aggressive China."

"We are here to learn . . . how we can deepen [the bilateral] relationship" and "support you and your effort . . . as you take on a more aggressive China," the United States agency's Chairperson Robin Cleveland told Lai at the Presidential Office.

"I don't think China is just aggressive in this region, it's globally," Cleveland said, underlining the need to "consider the broader context of how China is behaving in the world."

Meanwhile, Lai criticized China for escalating tensions across the Taiwan Strait and in the South China Sea through military and diplomatic actions. He called on the international community to "not let China draw red lines arbitrarily."

HOUSE PASSES REP. TIFFANY'S TAIWAN AMENDMENT SEEKING TO LIFT RESTRICTIONS ON U.S.-TAIWAN EXCHANGES

On June 27, U.S. Representative Tom Tiffany's (R-WI) Taiwan amendment passed the House as part of the "Department of State, Foreign Operations, and Related Programs Appropriations Act, 2025." The amendment seeks to lift the State Department's self-imposed restrictions on high-level U.S.-Taiwan visits and communications as outlined in the "Revised Guidelines on Interacting with Taiwan."

During his House floor remarks, Tiffany stated "my amendment would prevent the enforcement of arbitrary, self-imposed State Department rules that limit communication between U.S. officials and their counterparts in Taiwan."

"In essence, these guidelines are designed to prevent high-level coordination between our two countries. That isn't just bad policy, it is in direct conflict with existing laws that call for expanding bilateral cooperation, such as the Taiwan Travel Act."

The guidelines "even police language, warning American officials not to refer to Taiwan as a country or its elected leaders as a government," Tiffany said, adding that these directives "do not help the United States and they do not help Taiwan, but they do help the Chinese Communist Party."

"America should not have to ask China for a permission slip to talk to our friends and allies in Taiwan or anywhere else," he added.

U.S. HOUSE PASSES BILL WITH US\$500 MILLION IN MILITARY AID FOR TAIWAN

On June 28, the U.S. House of Representatives approved an appropriations bill for fiscal year 2025 that includes US\$500 million in military aid for Taiwan.

The appropriations bill, which authorizes funding for the Department of State, foreign operations, and related programs for 2025, passed 212-200 in the Republican-led House.

The bill stipulates that the U.S. would provide no less than US\$500 million in foreign military financing for Taiwan to strengthen deterrence across the Taiwan Strait, and offer Taiwan up to US\$2 billion in loans and loan guarantees for the same purpose.

Apart from military financing, the appropriations bill also states that no funding should be used to "create, procure, or display any map that inaccurately depicts the territory and social and economic system of Taiwan and the islands or island groups administered by Taiwan authorities."

CONGRESSIONAL TAIWAN CAUCUS CO-CHAIRS CONDEMN CHINA'S NEW GUIDELINES TARGETING PEOPLE OF TAIWAN

On July 12, U.S. Representatives Andy Barr (R-KY), Ami Bera (D-CA), Gerry Connolly (D-VA), and Mario Díaz-Balart (R-FL), Co-Chairs of the Congressional Taiwan Caucus, issued a statement condemning China's new guidelines targeting Taiwanese as an act that severely threatens regional stability and peace.

"As Taiwan Caucus Co-Chairs and strong advocates for robust U.S.-Taiwan relations, we strongly condemn the recent guidelines by the People's Republic of China [PRC], which include allowing the death penalty for individuals deemed advocates of Taiwan independence and finding them guilty in absentia."

"This escalatory move by Beijing represents a significant threat to peace and stability in the region," they said, adding that the "Congressional Taiwan Caucus will continue to stand with our key democratic partner, Taiwan, as it faces an increasingly belligerent and dangerous PRC."

TAIWAN HAS BEEN PAYING FOR ITS DEFENSE: U.S. STATE DEPARTMENT

Taiwan has been paying for its own defense, State Department Spokesman Matthew Miller emphasized on July 17, adding that Taiwan's purchases of U.S. military equipment are important to the U.S. economy and for ensuring regional security.

Miller was asked at a news conference about recent comments by former U.S. president Donald Trump, the Republican nominee in November's U.S. presidential election, who said that Taiwan should pay the U.S. for its defense during an interview with Bloomberg Businessweek.

"Taiwan has been purchasing military equipment from the United States to the tune of billions of dollars," Miller responded, adding that the purchases that Taiwan have made "not only are important . . . to regional security, but are important to the United States economy."

Citing the security cooperation that the U.S. has provided over the decades, Miller said Taiwan has purchased necessary military equipment and that "it has not been in any way charity from the United States."

TAIWAN IS ONE OF THE LARGEST BUYERS OF U.S. ARMS: REPUBLICAN LAWMAKERS

Two Republican lawmakers on July 17 said Taiwan is one of the biggest buyers of U.S. defense equipment and reiterated U.S. support for Taiwan.

U.S. Congressman Michael McCaul (R-TX), who chairs the House Foreign Affairs Committee, made the comments via email after he was asked by the Central News Agency (CNA) about Donald Trump's recent interview in which the former U.S. president said that Taiwan should pay the U.S. for its defense.

Trump "is right that U.S. allies should always play a significant role in their own defense," McCaul said. "Taiwan is a perfect example of what we want all our allies to do. They have consistently been one of the biggest buyers of U.S. weapons for its defense," he added.

U.S. Representative Mario Díaz-Balart (R-FL), Co-Chair of the Congressional Taiwan Caucus, and also Chairman of the House of Representatives State, Foreign Operations, and Related Programs Subcommittee, told CNA in a separate email that Taiwan has been "one of the largest buyers of U.S. defense equipment, purchased with Taiwan's own funding, supporting American businesses and jobs."

North American Taiwan Studies Association 29th Annual Conference


FAPA Panel at NATSA Conference

Taiwan International Solidarity Act

The "Taiwan International Solidarity Act" aims to counter China's distortion of UNGA Resolution 2758, fabricated claim of sovereignty over Taiwan, and growing efforts to exclude Taiwan from international organizations.

On September 28, 2023, U.S. Senators Chris Van Hollen (D-MD) and Mitt Romney (R-UT) introduced the Taiwan International Solidarity Act (S. 2995), which aims to counter China's distortion of the United Nations General Assembly (UNGA) Resolution 2758 and its fabricated claim of sovereignty over Taiwan.

While resolving the question of "China's representation" in the UN, the 1971 UNGA Resolution 2758 said nothing about Taiwan being "an integral part of China," nor did it give the Chinese government any right to represent Taiwan internationally. However, this UN resolution is still widely misused by China to "justify" its fictitious "One China principle," aimed at suppressing Taiwan's international status and space.

If passed into law, the Taiwan International Solidarity Act would help clarify that the UNGA Res. 2758 did not address the issues of Taiwan's territorial sovereignty and international representation. The Act would also require the United States to more proactively challenge China's fabricated sovereignty claim over Taiwan, and encourage the U.S. and its allies to oppose China's efforts to undermine Taiwan's diplomatic and international relations.

On July 25, 2023, the U.S. House unanimously passed an identical bill (H.R. 1176). We ask you to contact your Senators immediately, urging them to support and pass the Taiwan International Solidarity Act (S. 2995).

IN SUPPORT OF THE 528 BLUEBIRD MOVEMENT, WFTA AND FAPA INITIATE JOINT STATEMENT BY OVERSEAS TAIWANESE ORGANIZATIONS

(Full Text of the Statement)

The Bluebirds Spread Their Wings and Set out to Protect the Homeland - We Join Hands Together to Safeguard the Defense Line of Taiwan's Democracy!

Since the beginning of the 11th Legislative Yuan in February 2024, Taiwan's parliament, dominated by the main opposition Chinese Nationalist Party or Kuomintang (KMT) and the smaller Taiwan People's Party (TPP), has proposed a set of controversial "legislative reform" bills, many of whose contents directly contradict the Constitution. The quality of those bills is sloppy and poor, and the legislative process seriously violates procedural justice. Taiwan's democratic system is facing the most severe damage since the lifting of martial law.

The bills to expand the Legislature's powers, which were forcibly passed the third reading, eventually spurred massive protests by the Taiwanese people at the end of this May. Not only in front of the Legislative Yuan, but many people across the country also stood up like rising bluebirds. They would not allow abusive politicians to invade their privacy, violate the constitutional order, and harm the people's fundamental rights.

Most overseas Taiwanese cannot fly back to the homeland in time like bluebirds. Nevertheless, even in distant foreign lands, we still deeply care about Taiwan and support the determination of the Taiwanese people to defend democracy.

We condemn the KMT, the TPP, and those independent legislators who worked with the KMT for:

Forcing the third reading: The bills that arbitrarily expand the Legislature's powers
were passed without any substantive consideration and proper discussion as their
passages failed to implement committee review, safeguard the minority parties'
rights to propose, and honor legislators' rights to speak, all in violation of procedural
justice.

We also urge the KMT, the TPP, and those independent legislators who worked with the KMT to withdraw the bills after the Executive Yuan requests a reconsideration, and instead:

- Eliminate the unconstitutional power expansion clauses and strictly adhere to the separation of powers: The exercise of legislative power should not infringe on judicial power, supervisory power, or usurp administrative power;
- Remove the abuse of legislative power clauses and protect fundamental human rights: The Legislative Yuan must not exercise any power without limits. Any provisions involving or restricting the rights of the people must strictly abide by the principles of the rule of law, clearly set out the purpose, scope, and requirements, firmly adhere to the principle of proportionality, and unambiguously stipulate procedural safeguards, in particular, shall not deprive the people of their right to assistance of counsel;
- Add penalties for breach of duty by legislators: Any state power must be
 commensurate with its authorities and responsibilities. Greater power entails
 greater responsibility. The five "legislative reform" bills proposed by the KMT and
 TPP parties unidirectionally expand the Legislature's power without limits, but
 there are no sanctions or penalties for legislators who violate the code of conduct
 and obligations. The parliamentary monster seems to be about to break out of the
 fence!

We also call on all Taiwanese to continue to watch closely other KMT-TPP proposed bills that would endanger Taiwan, including bills that have already been put on the agenda or introduced:

- The three bills on Hualien-Taitung transportation, which lack environmental impact assessment and would cost as much as the Taiwan government's total annual budget;
- Proposals to shorten the naturalization process for Chinese spouses and to enact an absentee voting law that do not take into account Taiwan's political realities;
- Proposed amendments to the Anti-Infiltration Law that endanger Taiwan's national security.

Taiwan's democracy has never been the goodwill of the rulers, but has been guarded by the unremitting efforts of the Taiwanese people from generation to generation. The continuation of Taiwan's democracy and rule of law must be defended by all Taiwanese together. We call on all overseas Taiwanese to speak out in support of our relatives, friends, and partners in Taiwan, so that Taiwan's democracy can be sustained forever, and that the bluebirds can spread their wings freely and fly without fear.

《聲明全文》

廢除違憲擴權條款,嚴守權力分立:立法權之行使不應侵犯司法權、監察權、架空行政權; 廢除國會濫權條款,保障基本人權:立院行使任何權力不得漫無分際,任何涉及、限制人民權利之 條款必須嚴守法治國原則,明確訂立目的、範圍、要件,恪守比例原則,明定程序保障,尤其不得 剝奪人民的律師協助權;

增訂立委違反義務罰則:任何國家權力必須權責相符。更大的權力必須負起更大的責任。藍白兩黨提出的國會五法單向無限擴權,卻對違反行為準則及義務的立委毫無制裁、罰則,國會怪獸彷彿即將破欄而出!

我們也呼籲所有台灣人繼續監督藍白兩黨的接下來的危台法案,包括已經排案或已拋出的提議: 未經環評、花費達台灣政府一年總預算的花東交通三法;

未考量台灣政治現實的縮短中籍配偶入籍年限提案以及不在籍投票法;

危害台灣國安的反滲透法修改提案。





LET TAIWAN BE "TAIWAN" AT THE OLYMPICS!

July 26th, 2024, is the opening day of the 2024 Summer Olympics – FAPA calls on the International Olympic Committee (IOC) to let Taiwan's athletes compete under the name "Taiwan" instead of forcing Taiwanese to use the discriminatory misnomer, "Chinese Taipei."

Since 1984, under China's pressure, the IOC has forced Taiwan to participate in Olympic Games under the name "Chinese Taipei," using a non-national flag and anthem.

We want Taiwan to compete proudly as Taiwan!

As Reps. Tom Tiffany (R-WI), Andy Ogles (R-TN), and Chris Smith (R-NJ) noted in their open letter to the IOC in May 2024, even Puerto Rico and Bermuda are not forced to compete as "American San Juan" or "British Hamilton," though both are overseas territories. It is even more ridiculous to make Taiwan participate under the name "Chinese Taipei," for Taiwan has never been part of China, nor been controlled by the People's Republic of China (PRC).

The IOC must no longer succumb to China's pressure and bullying against Taiwan. The international community should support democracy and freedom by opposing China's attempts to undermine Taiwan's sovereignty and independent statehood through the imposition of the name "Chinese Taipei."

On June 18, 2024, Rep. Bill Huizenga (R-MI) introduced a resolution calling for the IOC to allow Taiwan to participate in the Summer Olympics under the national name, flag, and anthem of its own choosing. The resolution is co-sponsored by 9 representatives including longtime Taiwan champions Rep. Tom Tiffany (R-WI) and Rep. Michelle Steel (R-CA).

FAPA provided comments during the drafting of this resolution and successfully urged Rep. Huizenga's office to drop the phrase "Republic of China" and change the wording to allow Taiwan to compete under its chosen national name.

The Congressional resolution introduced expresses the sense of deep concern about the IOC's discriminatory requirement for Taiwan to compete as "Chinese Taipei," falsely implying Taiwan is part of China (PRC), even though Taiwan has never been ruled by the PRC for a single day.

On this day, FAPA calls on the IOC to stop its discriminatory and unfair practices and allow Taiwan to proudly compete as Taiwan!

正如美國聯邦眾議員帝芬尼(Tom Tiffany, R-WI)、奧格茲(Andy Ogles, R-TN)以及史密斯(Chris Smith, R-NJ)在2024年5月致國際奧委會的聯名信中所言,即便是波多黎各(Puerto Rico)及百慕達群島(Bermuda)這兩個海外屬地,都能選擇以自身名義參賽,並未被迫稱為「美屬聖胡安」(American San Juan)或「英屬漢密爾頓」(British Hamilton)。相較之下,台灣從未成為中國的一部份,亦未曾受中華人民共和國統治,竟被迫矮化以「中華台北」之名參賽,簡直荒謬至極。

台灣人公共事務會(FAPA)在此決議案的起草階段,應邀向美國眾議員惠曾佳辦公室提供意見, 並成功敦促其將「中華民國」一詞從草案中刪除,以讓台灣能自行選擇以何國名參賽。

此決議案旨在表達美國國會對國際奧委會施加台灣歧視性待遇的嚴重關切。強迫台灣以「中華台北」的名義參賽,更是錯誤地暗示台灣屬於中國(亦即,中華人民共和國)的一部分,即便台灣連一分一秒都不曾受過中共政權的統治。

FAPA INITIATES A JOINT LETTER TO THE IOC, URGING TO LET TAIWAN BE "TAIWAN" AT THE OLYMPICS

As the 2024 Paris Olympics comes to an end, the Formosan Association for Public Affairs (FAPA), together with 23 other overseas Taiwanese organizations, sent a joint letter today (August 9) to the International Olympic Committee (IOC) President Thomas Bach and all members of its Executive Board, calling on the IOC to justly let Taiwanese athletes compete under the name "Taiwan" instead of forcing Taiwan's team to use the discriminatory misnomer "Chinese Taipei," and also stop infringing on the "freedom of speech and expression" of the spectators to display signs and symbols in support of Taiwan at the Olympics.

The initiator of the joint letter, FAPA President Su-Mei Kao noted: "Taiwan is an independent, sovereign country, and this is a long-established 'status quo.' Taiwan's Olympic team is fully entitled to compete proudly under the name 'Taiwan.' It is only natural for Taiwanese fans to cheer for the team of their country 'Taiwan' at the Olympic Games. The IOC, in blatant disregard for the principles of 'non-discrimination' and 'political neutrality' enshrined in the Olympic Charter, has forced Taiwan's team to use the derogatory name 'Chinese Taipei,' which undermines Taiwan's independent statehood and national dignity. The reason behind this is obvious: China's outrageous political pressure and its irrational and continued bullying against Taiwan."

In the joint letter, we point out that since 1984, "capitulating to the political pressure from the People's Republic of China (PRC)," the IOC has unjustly forced Taiwan to participate in the Olympics under the name "Chinese Taipei" and prohibit the display of its national flag and the playing of its national anthem during the games.

The letter criticizes that these "unfair practices violate the fundamental principles of the Olympic Charter," which, among other things, declares that "[t]he practice of sport is a human right" and "[e]very individual must have access to the practice of sport, without discrimination," that "sports organisations within the Olympic Movement shall apply political neutrality," and that "[t]he enjoyment of the rights and freedoms set forth in this Olympic Charter shall be secured without discrimination of any kind, such as race . . . political or other opinion, national or social origin . . . birth or other status."

The letter says that the IOC's unfair Taiwan-specific restrictions have been extended to fans supporting "Taiwan." At the ongoing Summer Olympics, signs or items that have the word "Taiwan" on them, or include a semblance of Taiwan, have been unreasonably prohibited and forcefully snatched from Taiwanese fans by Olympic staff members or Chinese spectators. Fans holding signage in support of Taiwan have even been forcibly removed from the Olympic venues.

FAPA and other co-signatory organizations "strongly condemn these violent acts." These actions "not only violated the Olympic spirit and principles set forth in the Olympic Charter" but also infringed on the "freedom of speech" of Taiwanese spectators at the Olympics to rightfully express support for the athletes from their country, "Taiwan."

We jointly call on the IOC President Bach and the full Executive Board "not to succumb to China's political pressure" and immediately stop its "discriminatory requirement" for athletes from Taiwan to compete under the fictitious name "Chinese Taipei." The name "Chinese Taipei" "falsely implies that Taiwan is part of China (PRC), even though Taiwan has never been ruled by the PRC for a single day."

We demand and hope that Taiwan's team to compete proudly and properly under the name "Taiwan." We urged that "[t]he international community ought to support democracy and freedom by opposing authoritarian China's attempts to undermine Taiwan's sovereignty and independent statehood through the forcible imposition of the humiliating name 'Chinese Taipei' on Taiwan."

We praise that during this year's Olympic Games in Paris, various news outlets from different countries have properly explained that the team participating under the confusing name "Chinese Taipei" is actually from "Taiwan" and correctly referred to it and its members as the "team of Taiwan" and "Taiwanese athletes." We also encouraged more media outlets to follow suit and call Taiwan as "Taiwan."

At the end of the letter, FAPA and all co-signatory overseas Taiwanese organizations jointly urge the IOC President and other Olympic officials to "resist China's political bullying against Taiwan and begin sweeping away all discriminatory and unfair restraints on Taiwan's athletes and supporters."

We strongly call on "the IOC to live up to the ideals and principles of the Olympic Charter, allow Taiwan to proudly compete under its name, 'Taiwan,' and use the national flag and anthem that can truly represent Taiwan."

FAPA發起連署致函國際奧會 籲讓台灣選手以「台灣」之名參賽

隨著 2024 年巴黎奧運步入尾聲,台灣人公共事務會(FAPA)於今日(8月9日)協同其他 23 個海外台灣人組織,連署致函國際奧林匹克委員會(IOC)主席巴赫(Thomas Bach)及全體執行委員會委員,呼籲國際奧會應公正地允許台灣運動員得以「台灣」(Taiwan)之名義參賽,而非強迫台灣代表隊使用「中華台北」(Chinese Taipei)此歧視性的誤稱,並且應立即停止侵犯奧運場內觀眾高舉為「台灣」加油之標語或標誌的「言論與表意自由」。

發起連署信的FAPA會長林素梅表示:「台灣是個主權獨立的國家,這是長久以來所確立的『現狀』。台灣的奧運代表隊完全有資格以『台灣』之名驕傲地參賽。台灣觀眾在奧運場內為自己的國家『台灣』加油,乃是天經地義。國際奧會不惜違背《奧林匹克憲章》中的『非歧視』與『政治中立』等基本原則,強迫台灣代表隊使用有損國格與尊嚴的『中華台北』貶稱,其背後原因無他——亦即,中國的蠻橫政治壓力及其對台灣的無理持續霸凌。」

連署信函指出,自1984年以來,國際奧委會「屈服於中華人民共和國的政治壓力」,不公不義地強 迫台灣隊以「中華台北」的名義參加奧運,並禁止於賽事期間展示其國旗及播放其國歌。

連署信批評,「這些不公正的做法違反了《奧林匹克憲章》的基本原則」,其中包括「體育運動是一項人權。每個人均須享有從事體育運動的機會,而不受任何形式的歧視」,「奧林匹克活動中的運動組織應保持政治中立」,以及「應確保享有本《奧林匹克憲章》所規定的權利和自由,不受諸如種族...政治傾向或其他意見、國籍或社會出身...出生或其他身分等任何形式的歧視」。

信中提到,國際奧會針對台灣的不公平限制,竟已延伸至支持「台灣」的奧運場內觀眾。正在巴黎舉行的夏季奧運會上,帶有「台灣」字樣或包含台灣意象之標語或物品被無理地禁止,並從台灣粉絲手中被奧會保全人員或中國籍人士蠻橫搶走。手持標語或標誌為「台灣」加油的觀眾,甚至被工作人員強制驅離奧運賽場。

FAPA及其他參與連署的組織「強烈譴責這些暴力行為」。這些行為「不僅違反了《奧林匹克憲章》中的奧運精神與基本原則」,並且侵犯了台灣觀眾在奧運場內正當表達支持其自身國家「台灣」運動員的「言論與表意自由」。

我們共同呼籲,國際奧會巴赫主席與整個執行委員會「不應再屈從於中國的蠻橫政治壓力」,且應 立即停止強迫台灣運動員以「中華台北」此不實虛構名稱參賽的「歧視性要求」。「中華台北」此名 稱「錯誤地暗示台灣是中國(亦即,中華人民共和國)的一部分,即便台灣從未被中共政權統治過 一分一秒」。

我們要求並期盼台灣代表隊能以「台灣之名」合理且驕傲地參賽。我們呼籲,「國際社會應堅定捍衛民主與自由價值,公開反對威權中國強迫台灣使用『中華台北』此貶抑性的辱稱,企圖侵害台灣的國家主權尊嚴與獨立國格」。

我們要讚揚各國的多家新聞媒體在巴黎奧運期間,妥善解釋了使用「中華台北」此怪異名稱參賽 之隊伍其實來自「台灣」,並正確地稱呼該隊及其隊員為「台灣隊」與「台灣運動員」。我們並鼓 勵越來越多媒體僅以「台灣」來稱呼台灣。

在該信文末,FAPA及所有連署的海外台灣人組織共同呼籲,國際奧會主席與其他官員「能抵抗中國對台灣的政治霸凌,並著手消除所有對台灣運動員及支持者的歧視性待遇與不公平限制」。 我們強烈要求,「國際奧委會能恪遵《奧林匹克憲章》的理想和原則,允許台灣以其真實的名稱 『台灣』自豪地參賽,並讓其使用能真正代表台灣的國旗與國歌」。

FTSADC Lunar New Year Banquet



2023 National Advocacy Conference event and Senator office visit

Chapter members Yi-Ju Chen and Chia-Yen Wu attended the 2023 FAPA National Advocacy Conference events in DC from September 30th to October 2nd, 2023. On October 2nd, Yi-Ju, Chia-Yen, and other senior members (Minze Chien, Mark Kao, Chih-Chin Kuo, Ming-Yuan Lu) visited DE senators Tom Carper and Chris Coons offices. During the visit, the "Issues of Concern to Taiwan Americans" were presented and the US-Taiwan-China relationship was further discussed. We followed up on October 6th to ask for the senator's support on the bipartisan bill "Taiwan Representative Office Act" and shared the subscription link of "Taiwan This Week", which contains the latest Taiwan-related news with FAPA insight, to the Senators' office.

December 10th, 2023, Chapter members Yi-Ju and Chia-Yen served as Proxies on behalf of Cecilia Chi to attend the 2023 FAPA Board Meeting and joined the discussion.

Petition to support H.R. 7521 "Protecting Americans from Foreign Adversary Controlled Application Act"

On March 12, 2024, we requested our DE chapter members to sign the petition through the FAPA HQ website to ask the House of Representatives to support H.R. 7521 bill "Protecting Americans from Foreign Adversary Controlled Application Act ". We sent a letter to DE congresswoman Lisa Blunt Rochester and asked her to support H.R. 7521 bill. On March 20th, we received a response letter from Rep. Lisa Blunt Rochester mentioning that she voted to pass the bill and that she will continue to put an effort into issues relating to data privacy and data-sharing practices.

On May 25th, 2024, our FAPA Kansas Chapter had the honor of welcoming Professor Chen Shih-Fen 陳時奮 (pen name "Ontario" 翁達瑞) and his wife Hsieh Ming-Ling 謝銘鈴 to visit us for a lunch speech. The entire event lasted over 4 hours and everyone appeared to enjoy the time a lot. The speech title is "Adverse Outcomes in Taiwan's Elections: Causes and Solutions", which is in perfect sync with the on-going assembly with over 100,000 protestors outside Legislative Yuan in Taiwan. People of all ages from every walk of life gathered to voice their opinions, not allowing the absurd proposals to become laws for the newly elected legislators to expand their power in an excessive fashion. During the Q and A session, our members were very concerned with many current issues in Taiwan and Professor Chen offered his answers with educated reasoning. It turned out to be a successful chapter activity.

How did we first get started to have the thought of inviting Professor Chen to come to Kansas? Our weekend morning walk group began to pay attention to him through several social media reports and TV appearances. On heavily discussed topics and public figures, Professor Chen always provided very detailed analysis and trackable references. Besides, he has a longtime follower here - our own FAPA permanent member Jack Lin. Topics, ranging from Hsinchu Mayor Kao Hung-An's Ph.D. dissertation scandal to several highly publicized lawsuits, were brought to the public eyes under the spotlight. As of now, he won all of the court cases against him. The reason was simply because Professor Chen always supported his own remarks with verifiable data and accessible links. In 2023, I started reaching out to Professor Chen with the plan in mind to hold 2 chapter gatherings within the same year. In his early academic career, he taught a couple of years at Kansas State University and some of his friends also came to support our lunch speech event. That proved he got along with several people, so even after almost 25 years, they would still come to visit him to renew the friendship. In fact, Professor Chen and wife flew in one day before the event and then drove a rental car to see friends there and stay over for one night. They got up early the next morning and drove a couple of hours to our speech venue.

After the event was over, at 6:30pm, Dr. Fei-Tau Kung and wife Jane Kung personally invited Professor Chen and several guests to a restaurant "Jack's Stack BBQ". Barbecue sauces are what Kansas City has been famous for, so it was a very nice gesture by the Kungs to host the dinner the best way possible. We enjoyed the delicious food as well as insightful conversation again with Professor Chen and wife Ming-Ling. A group of over 20 Taiwanese Americans gathered at the office of Thomas Chen, CEO of Crystal Windows in Flushing, NY, where we met with Schumer and Mucarsell-Powell. The event, organized by Thomas Chen to support Mucarsell-Powell's 2024 Florida Senate campaign, featured Schumer as a special guest. Mucarsell-Powell is set to challenge incumbent Republican Senator Rick Scott, backed by Schumer's strong endorsement and fundraising support.

Schumer, a prominent Congressional leader, has long been a staunch supporter of Taiwan and joined the Senate Taiwan Caucus long ago. The NY-Hudson Chapter has fostered a close relationship with his office in DC, with members regularly engaging both in person and virtually with his aides.

In Memory of Former FL-S Chapter President Song-Yea Lee

Chapter President Ming-Lon Young 楊明倫 arranged a memorial service and funeral for the beloved ex-FAPA South Florida Chapter President Song Yea Lee 李嵩義前會長.



李嵩義

11/19/1940 - 5/24/2024

李嵩義兄於台灣草屯出生,1968年來到美國,是一位傑出的生物化學家,他於2018年退休。 在七十年代,所有台美人都對國民黨加諸台灣的長期戒嚴都非常關注。為了挑戰當時的局勢,在共同理念之下南佛州二十幾個家庭成立了台灣人公共事務會南佛州分會,寫信給國會議員並不時與他們見面,講述台灣的歷史與現況,分享台灣人的理念與願望,推動議員們在國會提出可以加強台灣民主、自由、安全的法案。經過這數十年,南佛州公共事務會的成員都凝聚了兄弟姊妹一般的友情。

嵩義大約1994到2004做過南佛州FAPA十年的會長。同時並任全美八位standing committee 的總召集人。任內經常安排與美國國會議員見面,包括前國會議長Dick Gephardt, 前俄亥俄州國會議員Sherrod Brown (現任參議員),以及佛州衆議員Peter Deutsch等,這些議員因此更了解台灣及台美人的意願。這些議員並由FAPA總部Follow-up,在國會提出有利台灣的法案,成為美國國會內支持台灣的重量級議員。

在與布羅瓦郡衆議員Peter Deutch言談中,嵩義兄讓他知道當時台美人最痛苦的事之一就是護照出生地要被寫成Taiwan, China,因此Peter Deutsch為台灣推出的法案中,最重要的是,讓美國護照上可以寫台灣為出生地,而不用寫中國、台灣。結果法案成功獲得通過,這我們第一得感謝嵩義兄的貢獻,第二也讓我們了解到FAPA 與各地分會的力量,不容小覷。 那年克林頓總統來佛州訪問,嵩義兄更獲得邀請,與總統一起在沙灘慢跑。為此,他也在台僑月刊8/25/1994寫下一篇詳細的報導:FAPA南佛州分會長李嵩義會見克林頓總統。

那段時間每次有聚會都在他的家中。有一次總部昆不老來南佛州演講,住在他家。聽到他從小養的兩隻鸚鵡會講很多台灣話,嚇了一跳,因為他以為美國的鸚鵡只會講英語呢!在嵩義離世前一星期,這兩隻鸚鵡雙雙離奇的死於非命,享年33歲,月華嫂即感受到這是不祥之兆。

當年FAPA財務困難,嵩義想要到並推出一項FAPA-100 membership計劃(每人每月捐一百為期兩年),因此穩定了FAPA財務。南佛州幾乎所有FAPA會員都是FAPA 100成員。南佛州分會在他領導之下,也三次獲頒(1996,1997,2002)最佳分會獎。

時至今日,嵩義兄還是南佛州FAPA五位理事之一。

在過世一星期前我問他,他的人生有什麼遺憾。他說:「遺憾的是,還沒有看到台灣獨立,(成為一個正常的國家)」。現在每個人都會說「愛台灣」,但是你就會感受到李嵩義畢生對台灣的愛護是如此真實、明顯,其他人是難以超越的。

為此,在李嵩義的葬禮中,FAPA副會長鍾佳君特地從Boston趕來致詞(會長人在台灣)。我們南佛州FAPA四位現存理事更是以FAPA旗覆棺之禮恭送嵩義兄最後的一程。

FAPA 旗覆棺之禮後合照:南佛州五位理事:邱永順、許清政、林晉裕、楊明倫、FAPA副會長鍾佳君以及過世的李嵩義理事遺像。

雖然嵩義兄美好的仗已經打過,他擎起的火炬我們還得要繼續傳承下去,讓他生前最後的遺憾變成我們加倍努力的動力。但願台美人能在FAPA的組織中,成立一個Song Yea Lee Memorial Fund,用來培養下一代年輕人,同時讓李嵩義的名字留傳、被後世台美人永遠紀念。


